Terms and Conditions Governing the Lion-OCBC Securities ETF 12,500 / 50,000 VOYAGE Miles Promotion 11 Apr – 30 April 2024 (the "Promotion")

Promotion Period

 The Promotion Period shall run from 11 April 2024 till 30 April 2024 (both dates inclusive), or such other period(s) as may be determined by Oversea-Chinese Banking Corporation Limited ("OCBC Bank") and OCBC Securities Private Limited ("OSPL") at their absolute discretion (the "Promotion Period").
